## Nomination Guidelines

### 2024 Queensland Philanthropy Awards

Queensland Gives invites nominations for the 2024 Queensland Philanthropy Awards. The Awards recognise those contributing at the highest level of philanthropic endeavour in Queensland.

The criteria for each award focuses on philanthropy that is outstanding in its generosity—effective and impactful—and that exemplifies qualities such as commitment, inspiration and leadership.

Recipients of the Emerging Philanthropist of the Year, Community Philanthropist of the Year and Philanthropy Innovation of the Year Awards will have the privilege of allocating a \$2,000 sponsored donation to their charity of choice.

All Queensland Philanthropy Awards Nominees will be included in our 2024 Philanthropy Awards digital campaign. Award recipients will be acknowledged in Queensland Gives' annual report, newsletter, media releases and at a public presentation subject to government restrictions.

The level of charitable dollars given, time dedicated to giving, dollars raised to support a charity, and the impact and potential to inspire others will be considered. Innovative approaches to philanthropy are welcome. The Awards Committee may consider a present or former Queensland resident, a giving circle, a family unit, or a philanthropist who is deceased.

Nominations may be submitted in one or more of the following categories to acknowledge an outstanding individual or organisation furthering non-profit causes:

- 1 Queensland Corporate Philanthropist of the Year sponsored by QIC
- 2 Queensland SME Philanthropist of the Year sponsored by Deloitte
- 3 Queensland Community Philanthropist of the Year sponsored by Anglo American
- 4 Queensland Emerging Philanthropist of the Year sponsored by Perpetual
- 5 Queensland Philanthropy Innovation of the Year sponsored by QUT
- 6 Queensland Environmental Philanthropist of the Year sponsored by Goodman Private Wealth
- 7 Queensland Philanthropic Foundation of the Year sponsored by The Public Trustee

## GENERAL ELIGIBILITY CRITERIA

All nominees must have:

- Resided or operated in Queensland;
- A demonstrated track record of philanthropic support to non-profit organisations servicing Queensland;
- Made a positive impact on the lives of Queenslanders through their giving; and
- Encouraged/motivated others to become philanthropic.

## TERMS

All nominations must abide by the following terms and conditions:

- Submissions must be made online and automatically constitutes the nominee's and nominator's acceptance of all terms and permission to publish, if successful.
- Queensland Gives will require photographs of the successful recipient and relevant photographs relating to their philanthropic activities.
- Philanthropic endeavours must benefit non-profit organisations in Queensland and may also encompass individuals.
- Information is to be relevant, and meet the conditions of entry.
- It is highly recommended that nominators give a full account of all the nominee's philanthropic endeavours. To achieve this, it is desirable this is done in collaboration with the nominee.
- Awards will be announced in June 2024.
- Previous award recipients are not eligible for nomination for the same award, however past nominees may be nominated again.
- Nominees must be available to be interviewed for media opportunities.
- Contact details of nominee must be current to allow Queensland Gives access for further information relating to their nomination.
