### Tax deductible

All donations are tax deductible.



### Low Cost

Every dollar donated to QCF is invested in perpetuity. The day-to-day administration and marketing of the fund is met by our sponsors: QIC, The Public Trustee and Anglo American.



### Fees

The Public Trustee charges a Trustee Fee of 6.6% of the income received by the Trust, for acting as Trustee, and an investment management fee at a rate not exceeding 1.61% of the market value of the funds per annum (before rebate).



### Secure

The Public Trustee of Queensland is the Trustee providing integrity, permanence and security. QIC—one of Australia's leading investment advisors—is the investment manager. QCF is registered with the Australian Charities and Not-for-profits Commission.



### Easy

There are no set-up costs or administrative burden usually associated with establishing and running your own charitable fund or foundation. QCF takes care of all reporting requirements, compliance, independently audited by QAO due diligence and administration measures. Significantly more cost effective than setting up a private ancillary fund.

The Toowoomba Region Community Fund (TRCF) is a perpetual fund and is the perfect way to support the Toowoomba Region today, and for generations to come.

All monies donated are tax deductible and are combined to establish a perpetual fund, the income of which is returned to the community via community grants administered by the TRCF.

The TRCF is a sub fund of the Queensland Community Fund (QCF), which oversees similar funds throughout the state. The TRCF committee administers the grants to support of local organisations involved in areas like community wellbeing, health, arts and culture, animal welfare, disability, children and youth, and the environment.
